

## ORDER OF AN EXECUTIVE OFFICER

**To:** Sehaj & Diya Holdings LTD. Rana Shalki Chandra Baral "the Owner" "the Owner"

**RE:** Those housing premises located in Edmonton, Alberta and municipally described as:

Common – 11935 101 Street NW Edmonton, AB T5G 2B8

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. The lock for the back door was in disrepair. As a result, it was not possible to properly lock and secure the building.
- b. There were signs of occupation within the crawl space below the back stairs. This included bedding, empty liquor bottles, and reports from tenants the space was being occupied. There was no means of emergency egress from this space.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. The lock for the back door was in disrepair. As a result, it was not possible to properly lock and secure the building. This is in contravention of Section 3(a) of the Minimum Housing and Health Standards, which states that "Exterior windows and doors shall be capable of being secured."
- b. There were signs of occupation within the crawl space below the back stairs. This included bedding, empty liquor bottles, and reports from tenants the space was being occupied. There was no means of emergency egress from this space. This is in contravention of Section 3(b)(i) of the Minimum Housing and Health Standards, which states that "For buildings of 3 storeys or less and except where a bedroom door provides access directly to the exterior or the suite is sprinklered, each bedroom shall have at least one outside window which may be opened from the inside without the use of tools or special knowledge."

## NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Repair or replace the lock for the back door of the facility. The lock must be maintained in proper operating condition and be capable of securing the door.
  - b. Remove the items from the crawl space below the back stairs. Secure this space to prevent it from being occupied in the future.

2. The work referred to in paragraph 1 shall be completed by October 3, 2025.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
