

ORDER OF AN EXECUTIVE OFFICER

- To: Van Vuong, &, Phan Hong, "the Owners"
- **RE:** Those housing premises located in Sturgeon County, Alberta and municipally described as: 26023 Township Road 544 Unit 201, Sturgeon County.

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. The master bedroom walk-in-shower is leaking through the floor onto the garage ceiling whenever the shower faucet is turned on. It is undetermined whether the leaking product is from potable water or wastewater.
- b. Rotted building materials are present on the garage ceiling as result of the leak occurring from the master bedroom walk-in-shower.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. The master bedroom walk-in-shower is leaking through the floor onto the garage ceiling whenever the shower faucet is turned on. It is undetermined whether the leaking product is from potable water or wastewater. This is in contravention of **Section 6** (*c*) of the *Minimum Housing and Health Standards*, which states, "*Every housing premises shall be connected to the public sewage system, or to an approved private sewage disposal system. All plumbing fixtures shall be serviceable, free from leaks, trapped and vented to the outside" and Section 3(2) of the Housing Regulation, AR 173/99, which states, "An owner shall ensure that the housing premises' plumbing system and facilities provided under subsection (1)(b) are free from defects and maintained in proper operating condition".*
- b. Rotted building materials are present on the garage ceiling as result of the leak occurring from the master bedroom walk-in-shower. This is in contravention of Section 1 (c) of the Minimum Housing and Health Standards, which states, "Good repair, safe condition, and structurally sound. (c) Building materials that have been damaged or show evidence of rot or other deterioration shall be repaired or replaced" and Section 3(1)(iii) of the Housing Regulation, AR 173/99, which states, "Subject to subsection (3) and section 4, an owner shall ensure that in good repair".

NOW THEREFORE, I hereby ORDER and DIRECT:

- 1. That the Owners immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Investigate and repair the source of the leak.
 - b. Remove and replace all rotted building materials around the shower surround, subfloor level, and garage ceiling. Photographs of investigation, removal of water damage material and installation of new materials must be submitted to local Environmental Public Health Office. Alternatively, a copy of the Safety Codes Officer – Building Discipline inspection report would be required.
 - 2. The work referred to in paragraph 1 shall be completed by April 27, 2025.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
