

## ORDER OF AN EXECUTIVE OFFICER

**To:** Rick Wheeler and Tasha Spychka  
"the Owner"

**RE:** Those premises located in St. Albert, Alberta and municipally described as:  
3 Mission Avenue

**WHEREAS** I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. There was no electrical service to the house and therefore there was no power to any of the fixtures in the rental accommodation.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. There was no electrical service to the house. This is in contravention of section 11 of the Minimum Housing and Health Standards which states that: "Every housing premises shall be supplied with electrical service."

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Ensure the housing premise is supplied with electrical service at all times.
2. The work referred to in paragraph 1 shall be completed by July 11, 2018.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
