WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted home-based personal service facility pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions may exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. There were reasonable and probable grounds to suspect that the operators were conducting invasive and potentially invasive personal service activities in a previously uninspected home-based setting.
- b. The owner was committing and maintaining a nuisance in the public facility.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act exist in and about the above noted premise, namely:

- a. Nuisance and General Sanitation Regulation (AR243/2003):
There were reasonable and probable grounds to suspect that the operators were conducting invasive and potentially invasive personal service activities in a previously uninspected home-based setting, which is in contravention of Part 1, Section 2(1) of the Nuisance and General Sanitation Regulation (AR 243/2003).

AND WHEREAS, by virtue of the foregoing, the above noted personal service setting is hereby declared to be **CLOSED**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the owner and operators shall cease the provision of all personal services including, but not limited to, hair styling, permanent make-up & tattooing and esthetics in the above noted premise until written permission has been granted by our office to commence.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
