

FOOD HANDLING PERMIT NOTICE OF SUSPENSION

To: **John and Monica Oshvalda**
“the Owner”

RE: The establishment located in Parkland County, Alberta and municipally described as: Mojo Garden Centre, and/or Mojo Garden Centre and Diner, 53310 Highway 43.

This notice is to inform you that your food handling permit for the **Diner building only**, including associated kitchen (collectively, the “**Establishment**”), has been suspended pursuant to s 11(b) of the *Food Regulation*, Alta Regulation 31/2006, due to the following reasons:

1. Executive Officer - Closure Order dated August 4, 2021 (the “**August 4th Closure Order**”) in place for the Establishment.

In order for the suspension to be lifted, the following criteria must be met:

1. All requirements noted in the August 4th Closure Order are complied with, including:
 - a. Securing the approval of the Parkland County Safety Codes office and Alberta Safety Code for the Establishment’s:
 - i. Septic disposal system;
 - ii. Ventilation and fire suppression system, as required for the Establishment’s food preparation activities; and
 - iii. Potable water well.
 - b. Receive and secure from Parkland County Safety Codes the following permits:
 - i. Occupancy Permit; and
 - ii. Fire Permit; and
2. The August 4th Closure Order has been rescinded by an AHS Executive Officer

The suspension will be reviewed with you at an administrative meeting which will be scheduled once we have determined that you are able to operate in compliance with the above criteria.

Please note the Food Handling permit for the Mobile food vending cart remains valid and in place.
