

**ORDER OF AN EXECUTIVE OFFICER
UNFIT FOR HUMAN HABITATION
ORDER TO VACATE**

And To: All Occupant(s) of the following Housing premises:

RE: Those housing premises located in the Municipal District of Greenview No. 16, Alberta and municipally described as:
22255 Township Road 720
Lot 1, Block 1, Plan 2022260
5; 22; 71; 34; NW

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have received a report about the above noted premises pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such report received disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. Based on the information received from the Royal Canadian Mounted Police (RCMP), the premises was used in the production of fentanyl. RCMP observed packaged drugs in the premises and could not rule out the possibility of the premises being contaminated by fentanyl.

AND WHEREAS such report received disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. Based on the information received from the Royal Canadian Mounted Police (RCMP), the premises was used in the production of fentanyl. RCMP observed packaged drugs in the premises and could not rule out the possibility of the premises being contaminated by fentanyl. This is in contravention of section 5(2) of the Housing Regulation which states that: "No person shall cause or permit any condition in housing premises that is or may become injurious or dangerous to the public health, including any condition that may hinder in any way the prevention or suppression of disease."

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Unfit for Human Habitation**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the premises remain unoccupied.
2. That the owner immediately secures the above noted premises from unauthorized entry.
3. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Hire the services of a professional remediation company that specializes in hazardous materials remediation to clean the premises of fentanyl contamination. Cleaning of the premises must be completed in such a manner that protects the public and future occupants from fentanyl contamination during and after the cleanup.
 - b. Submit a remediation plan to an Executive Officer of Alberta Health Services for approval and acceptance prior to undertaking any clean-up of the premises.
 - c. Provide documentation of all work completed to an Executive Officer of Alberta Health Services.
4. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain vacant and secure from unauthorized entry.

The above conditions were noted at the time of receiving the report and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
