

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

To: Inna's Foods Ltd.
And to: Inna Osadcha
"the Owners"

RE: The food establishment located in Hinton, Alberta and municipally described as:
Inna's Food Truck - CGY-1786

WHEREAS I, an **Executive Officer of Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. Potable hot running water supply was not available in the food establishment.
- b. Approved food contact surface chemical sanitizer was not available in the food establishment.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted premises, namely:

- a. Potable hot running water supply was not available in the food establishment, which is in violation of **Section 17(1)(f)(i) of the Food Regulation, AR 31/2006** that states "an operator must ensure that the commercial food establishment is supplied with hot and cold running water that is safe for human consumption and available in quantities sufficient to meet the needs of the food establishment".
- b. Approved food contact surface chemical sanitizer was not available in the food establishment, which is in contravention of **Section 28(2) of the Food Regulation, AR 31/2006** which states that commercial food establishment, all equipment, utensils, and all food contact surfaces must be maintained in a sanitary condition and must be washed and sanitized in a manner that removes contamination.

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owners immediately close the above noted premises.

2. That the Owners immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Restore potable hot running water supply in the food establishment in adequate quantity, pressure, and temperature. Ensure that the hand sink and the dishwashing sink are equipped with potable hot running water.
 - b. Provide a chemical food contact surface sanitizer approved for use in a food establishment and implement use.

3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
