

## **ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE**

**To:** Karen Greaves  
"the Owner"

**RE:** Those premises located in Peace River, Alberta and municipally described as:  
Karen's Homestyle Cooking, located at: 9703 100 Street.

**WHEREAS** I, an **Executive Officer of Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** the Chief Medical Officer of Health (CMOH) has issued the following Records Of Decision – CMOH Order 44-2021, 45-2020, of the Public Health Act, as may be amended or varied by subsequent Records of Decision, in response to a public health emergency,

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises in contravention of one or more of the above orders of the CMOH and which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. The indoor dining area of the premises was open to patrons in contravention of CMOH Order 44-2021. Food and beverage are being served while not running the Restriction Exemption Program.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act and CMOH Order 10-2021 exist in and about the above noted premises, namely:

- a. The indoor dining area of the premises was open to patrons in contravention of CMOH Order 44-2021. Food and beverage were being served which is in a contravention of section 10.1 of CMOH Order 44-2021 which states, "*An operator of a food-serving business or entity is prohibited from offering or providing indoor food and beverage services.*"

**AND WHEREAS**, by virtue of the above orders of the CMOH, the above noted premises are hereby prohibited from allowing public access into the indoor dining area of the business and are hereby declared to be **Closed for Dine-In Services**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the owners and the manager IMMEDIATELY CLOSE the indoor dining area of the premises to the public.
2. That the Owners and the Manager immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. The indoor dining service area of the premise must remain closed to the public for food and beverage service until the CMOH order allows indoor dining service to be open or the facility implements the Restriction Exemption Program under CMOH Order 45-2021.
  - b. Post a signage indicating that indoor dining is currently closed to public while applicable CMOH order is in effect.
  - c. Implement and execute plans for outdoor patio service, take away, delivery or other appropriate means of food service.
3. The above noted indoor dining area of the premises shall remain closed until such time that this Order is rescinded by an Executive Officer of Alberta Health Services.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
