

## **ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE**

**To:** Brenda Dalzell  
"owner"

**RE:** The food establishment Chubby Sisters, located at 266 Laval Boulevard W. in Lethbridge, Alberta

**WHEREAS** I, an **Executive Officer of Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such investigation disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. Operation of a Food Establishment without a valid permit

**AND WHEREAS** such investigation disclosed that the following breach of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted food establishment, namely:

- a. The food establishment is operating without a valid food permit in breach of the Food Regulation AR 31/2006 section 3(1)(a)

**AND WHEREAS**, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the owner immediately cease operations of the above noted food establishment;
2. That the owner immediately decommission the website and all other forms of advertisement or sales pertaining to Chubby Sisters products;
3. That the owner refrain from selling any product manufactured without approval in unapproved premises;
4. That the owner obtain approval and all permits required to operate the food business;
5. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted food establishment shall remain closed.

**YOU HAVE THE RIGHT TO APPEAL**

A person who a) is directly affected by a decision of a Regional Health Authority, and  
b) feels himself aggrieved by the decision

may appeal the decision within ten (10) days after receiving the order to the Public Health Appeal Board located at Reception, Main Floor. Telus Plaza, 10025 Jasper Avenue, Edmonton, Alberta, T5J 1S6, Telephone 780-427-2813 Fax 780-422-0914.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal. If you appeal, you may also make an application to the Board for a stay of this Order pending the appeal.

You are advised that all orders remain in effect pending such an appeal.
