

ORDER OF AN EXECUTIVE OFFICER

To: Tim Seitz
"the Owner"

RE: Those housing premises located in Medicine Hat, Alberta and municipally described as:
181 Fairchild Street SW

WHEREAS I, an **Executive Officer of Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. A bed bug infestation was observed in the first bedroom.
- b. Evidence of bed bugs was observed in the back bedroom. Evidence included blood and fecal staining on the mattress.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. There is a bed bug infestation. This is in contravention of section 16 (a) of the Minimum Housing and Health Standards which states: "The owner shall ensure that the housing premises are free of insect and rodent infestations"

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Obtain a certified pest control operator to address the bed bug infestation.
2. The work referred to in paragraph 1 shall be completed by 28 July 2021.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
