RE: Those premises located in Municipality of Crowsnest Pass, Alberta and municipally described as: Lots: 11-14, Block: 2, Plan: 3319I, 2022 & 2034-129 Street, Unit 1 Blairmore, AB.

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the **Public Health Act**, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, in contravention of the Public Health Act and Nuisance and General Sanitation Regulation, Alberta Regulation 243/2003 namely:

- a. The unit was filled with accumulated material, newspapers, and other items 3' to 4' high with cleared floor paths. This contributed to fire load and provided rodent harborage.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Nuisance and General Sanitation Regulation, AR 243/2003 exist in and about the above noted premises, namely:

- a. The unit was filled with accumulated material, newspapers, and other items 3' to 4' high with cleared floor paths. This contributed to fire load and provided rodent harborage. This is in violation of section 2(1) of the Nuisance and General Sanitation Regulation, AR 243/2003 which states that: No person shall create, commit or maintain a nuisance.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Remove accumulated material, newspapers, and other items.
 - b. Ensure all Housing Regulation requirements are met throughout the unit prior to any public accommodation.

2. The work referred to in paragraph 1 shall be completed by February 28, 2026.
