

ORDER OF AN EXECUTIVE OFFICER

To: Govind Reddy; John and June Hartley

RE: Those housing premises located in Lethbridge, Alberta and municipally described as:

226 McGill Boulevard W - Unit A

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. The dining room light fixture doesn't work.
- b. A portion of the kickplate/baseboard at the bottom of the kitchen counter is missing. This creates a difficult to clean gap in the flooring filled with grime.
- c. There is an overhang in the backyard covered in drug paraphernalia leftover from previous tenants.
- d. There is a bedroom window that is held together with a shoelace on a screw. In addition to this being in poor repair, the window sash could fall out onto someone below.
- e. The stair railing is pulling off the wall.
- f. The stair nosing is falling apart.
- g. The latch plate on the front door is missing a screw and is very loose.
- h. Most of the openable windows in this home are missing insect screens.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. The dining room light fixture doesn't work which is in contravention of section IV(11) of the Minimum Housing and Health Standards which states that: Every housing premises shall be supplied with electrical service. Outlets, switches and fixtures shall be properly installed and shall be maintained in a good and safe working condition.
- b. A portion of the kickplate/baseboard at the bottom of the kitchen counter is missing which is in contravention of section III(5)(b) of the Minimum Housing and Health Standards which states that: Rooms and sections of rooms that are used for food preparation and cooking shall have walls and floors constructed of materials which do not provide harbourage to dirt, grease, vermin and bacteria and that are easily kept clean.

- c. There is an overhang in the backyard covered in drug paraphernalia leftover from previous tenants which is in contravention of section 5(2) of the Housing Regulation which states that: No person shall cause or permit any condition in housing premises that is or may become injurious or dangerous to the public health, including any condition that may hinder in any way the prevention or suppression of disease.
- d. There is a bedroom window that is held together with a shoelace on a screw which is in contravention of section III(2)(b)(i) of the Minimum Housing and Health Standards which states that: All windows and exterior doors shall be; maintained in good repair, free of cracks and weatherproof.
- e. The stair railing is pulling off the wall which is in contravention of section III(3)(c) of the Minimum Housing and Health Standards which states that: Inside or outside stairs or porches including all treads, risers, supporting structural members, rails, guards and balconies, shall be maintained in good repair and shall comply with the requirements of the Alberta Building Code or a Professional Engineer design.
- f. The stair nosing is falling apart which is in contravention of section III(5) of the Minimum Housing and Health Standards which states that: All walls, windows, ceilings, floors, and floor coverings shall be maintained in good repair, free of cracks, holes, loose or lifting coverings and in a condition that renders it easy to clean.
- g. The latch plate on the front door is missing a screw and is very loose which is in contravention of section III(2)(b)(i) of the Minimum Housing and Health Standards which states that: All windows and exterior doors shall be; maintained in good repair, free of cracks and weatherproof.
- h. Most of the openable windows in this home are missing insect screens which is in contravention of section III(2)(b)(iii) of the Minimum Housing and Health Standards which states that: During the portion of the year when there is a need for protection against flies and other flying insects, every window or other device intended for ventilation shall be supplied with effective screens.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Ensure the light fixture is repaired or replaced.
 - b. Ensure the finishes under the counter are replaced.
 - c. Clean up the drug paraphernalia on the overhang.
 - d. Completely repair this bedroom window. Ensure that it opens and closes as intended.
 - e. Ensure that the railing is sturdy and securely attached to the wall.

 - f. Replace the damaged stair nosing.
 - g. Repair the latch plate on the door.
 - h. Ensure all openable windows have insect screens.
- 2. The work referred to in paragraph 1 shall be completed by November 21, 2022.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
