

## ORDER OF AN EXECUTIVE OFFICER

**To:** AVENUE LIVING (2014) GP LTD.; Avenue Living Communities Ltd.; Madison Howell;

Mae Cote "the Owner"

RE: Those housing premises located in Brooks, Alberta and municipally described as: 524 1A

Avenue E, Unit 108

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. The floor transition was missing in the hallway.
- b. The wall next to the water damaged bathroom vanity was showing the appearance of mold.
- c. The bathroom vanity and counter were water damaged.
- d. The tank on the toilet was cracked and leaking.
- e. Several screws were missing on the front entrance door hinges, compromising the door installation.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. The floor transition was missing in the hallway. This contravenes section III(5) of the Minimum Housing and Health Standards which states that: All walls, windows, ceilings, floors, and floor coverings shall be maintained in good repair, free of cracks, holes, loose or lifting coverings and in a condition that renders it easy to clean.
- b. The wall next to the water damaged bathroom vanity was showing the appearance of mold. This contravenes section III(5) of the Minimum Housing and Health Standards which states that: All walls, windows, ceilings, floors, and floor coverings shall be maintained in good repair, free of cracks, holes, loose or lifting coverings and in a condition that renders it easy to clean.
- c. The bathroom vanity and counter were water damaged. This contravenes section III(1)(c) of the Minimum Housing and Health Standards which states that: Building materials that have been damaged or show evidence of rot or other deterioration shall be repaired or replaced.
- d. The tank on the toilet was cracked and leaking. This contravenes section IV(6)(c) of the Minimum Housing and Health Standards which states that: All plumbing fixtures shall be serviceable, free from leaks, trapped and vented to the outside.
- e. Several screws were missing on the front entrance door hinges, compromising the door installation. This contravenes section III(3) of the Minimum Housing and Health Standards which states that: Exterior windows and doors shall be capable of being secured.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Replace floor transition
  - b. Remove water damaged vanity and repair affected wall damage. All water damaged building materials that show evidence of rot must be removed and replaced.
  - c. Replace the toilet.
  - d. Replace hinge screws to properly secure the door to the frame.
- 2. The work referred to in paragraph 1 shall be completed by August 1, 2025.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
