

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

To: Dana Janzen
"the Owner"

RE: The unapproved food establishment located in Municipal District of Pincher Creek, Alberta and municipally described as: NE-30-5-28 W4M, 5432 RR 28-5.

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. Food is being handled in a facility that is not an approved Food Establishment.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted premises, namely:

- a. Food is being handled in a facility that is not an approved Food Establishment which is in contravention of Section 3(2) of the Alberta Food Regulation (AR 31/2006) which states: "Subject to section 2(2) and Parts 3 and 5, no person shall handle food except in an approved food establishment."

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.


NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately cease the production of foods for sale to the public in the unapproved food establishment.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
