

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

To: Kevin Owczar

"the Owner" Cam Randall "the operator"

RE: The "pool" located in Lethbridge, Alberta and municipally described as:

Superlodge Lethbridge; 2210 7 Avenue S

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. There is no automated chemical feeding system for the pool.
- b. There is no pool permit for this swimming pool.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Public Swimming Pools Regulation, Alberta Regulation 204/2014 and the Pool Standards there under exist in and about the above noted premises, namely:

- a. There is no automated chemical feeding system for the pool which is in contravention of section 15(1) of the Public Swimming Pools Regulation which states that: a public swimming pool must be equipped with automated chemical feeding and monitoring equipment for pH and chlorine.
- b. There is no pool permit for this swimming pool which is in contravention of section 7(1) of the Public Swimming Pools Regulation which states that: No person shall operate a pool without a permit issued in accordance with this section

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately close the above noted premises.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Install an automated chemical feeding and monitoring system for chlorine and pH.
 - b. Apply for a Pool Permit and include the following information:
 - i. a site plan

- ii. a floor plan
- iii. a structural plan
- iv. a mechanical plan
- v. a description of the method of waste water disposal
- vi. a diagram showing the location and dimensions of the diving, swimming and deck areas, if any
- vii. the volume of each public swimming pool
- viii. the maximum design bather load at any given time
- ix. a description of the type of disinfectant, delivery system, chlorinator capacity, automatic monitoring and feeding equipment
- x. detailed drawings of the water circulation system, filtration equipment, disinfection equipment and all related equipment
- xi. a description of:
 - 1. the filter area, type and rate,
 - 2. the filtration gauges for measuring pressure change,
 - 3. the turnover rate.
 - 4. the rate of flow indicators.
 - 5. temperature indicators to be installed on the inlet and outlet of all heating equipment,
 - 6. the number of inlets,
 - 7. the number of skimmers or gutter drains,
 - 8. the pool finishes and colour of basin,
 - 9. the make up water source,
 - 10. the type of backflow prevention used on the make up water source,
 - 11. the main drains,
 - 12. the anti-entrapment devices, including information about the certification of submerged suction outlets, and
 - 13. the water testing equipment;
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
