

## **ORDER OF AN EXECUTIVE OFFICER Boil Water Order**

**To:**           **The Barn Store & Bear  
Country Inn / Jeff Uibel**  
                  "the Owner"

**RE:**       The Drinking Water Supply located at property known as The Barn Store & Bear Country Inn – Plan 2010552, Block6, Lot 8 – 525 Main St at the hamlet of Mountain View, Cardston County, Alberta.

**WHEREAS** I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted drinking water supply pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted drinking water supply which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. The UV light system used for disinfecting the water supply serving The Barn Store & Bear Country Inn has been disconnected/not operational and therefore the water used for human consumption was not properly disinfected. The water may be unsafe for human consumption due to no disinfection.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act Nuisance and General Sanitation Regulation, Alberta Regulation 243/2003 exist in and about the above noted Drinking Water Supply, namely:

- a. The UV light system used for disinfecting the water supply serving The Barn Store & Bear Country Inn has been disconnected/not operational and therefore the water used for human consumption was not properly disinfected. The water may be unsafe for human consumption due to no disinfection. This is in contravention of the Nuisance and General Sanitation Regulation Section 11, which states "Where a person provided a source of water that the person intends to be used or realizes or ought to realize will be used by the public for human consumption, the person shall ensure that the water is potable".

**AND WHEREAS** by virtue of the foregoing, the above noted Drinking Water Supply maybe **unfit for human consumption**;

**NOW THEREFORE**, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately issues a Boil Water Advisory to all users of the above noted Drinking Water Supply.
2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted drinking water supply, namely:
  - a. Advise all affected users of this well water supply, that water used for drinking, making infant formula, juices, making ice, washing fruits and vegetables, or brushing teeth, must be boiled for at least 1 minute prior to use.

- b. Install a drinking water disinfection system that meets the specification outlined in the *Public health guidelines for non-municipal drinking water*
  - c. Flush and disinfect thoroughly the water lines in the distribution system.
3. The work referred to in paragraph 2 shall be completed immediately.
4. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an Executive Officer of Alberta Health Services, that this order shall remain in effect.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
