Expanded competency statements including clarifying required education and training expectations for all health care providers. Reordering of the sections to reflect the sequence that activities involved in blood component and blood product transfusion occur. Expanding and clarifying content for activities that we know are error prone (from RLS and SIM lab reports). Addition of a new section called Emergency Unmatched Transfusion. Aligning with Connect Care workflows. Clarity to the two-person verbal check process. Direction on management of medication with a blood transfusion. Clarity for infusion rates for the first 15 minutes of blood component transfusions. Practice about pre-transfusion vital signs, vital signs requirements during the first 15 minutes of blood component transfusions, and monitoring post-transfusion requirements.
