Key Message

- The College of Physicians and Surgeons of Alberta (CPSA) will be performing an on-site assessment of the North Zone Laboratories
 - Edson, Hinton. Grande Cache, and Seton-Jasper during the week of September 9-12, 2024
 - Peace River, Manning, Grimshaw Berwyn, Fairview, Spirit River (Central Peace), and Beaverlodge during the week of September 23-26, 2024
 - La Crete, High Level (Northwest), and Fort Vermilion (St. Theresa) during the week of October 1-3, 2024
 - Fort McMurray (Northern Lights) October 21, 2024
 - Westlock, Wabasca Desmarais, Barrhead, Whitecourt, Mayerthorpe, Fox Creek, and Valleyview during the week of October 28 - November 1, 2024
- CPSA inspectors will also visit clinical areas to assess compliance with standards related to activities
 performed outside the lab, including transfusion of blood components and blood products.

Background

- CPSA standards require formal training and competency assessment of all medical, clinical and support staff involved in any transfusion related activity.
- The recently revised <u>AHS Transfusion of Blood Components and Blood Products Policy</u> supports these requirements.
- Provincially standardized education and competency assessment for transfusion of blood components and products is being implemented in a phased-in approach.

How this will impact you

 If your area is involved with ordering, handling, transporting, collection of type and screen, and/or administration of blood components and blood products, CPSA inspectors may visit your area to assess compliance with standards.

Action Required

- Be familiar with the <u>AHS Transfusion of Blood Components and Blood Products Policy</u>.
- Use the Blood Transfusion Education Requirements
 (https://insite.albertahealthservices.ca/Main/assets/tms/hpsp/tms-hpsp-tme-blood-trans-ed-req-dec-tool.pdf)
 decision tool to determine the requirements for your role.
- Existing training and competency assessment records must be available to share with inspectors if requested. (e.g. MyLearningLink, Lippincott Procedures, skills days, training records, or other records available at your site).
