

Patient Instructions - Testing Semen for Post Vasectomy

For correct test results, follow these instructions carefully. Incorrect test results can cause an important medical problem to be missed, or the ordering of more or unneeded tests.

| Before collection | Do not ejaculate (either through sexual intercourse or masturbating) for at least 3 days before collection. Collect a sample in the sterile container provided by the laboratory or your doctor. Do not collect the sample in a condom. Condoms contain a powder that destroys spermatozoa. | | | |

| After collection | Sample will ONLY be accepted if: | | | |
| | Collected in sterile container provided by laboratory or your doctor. Container must be labeled with patient's first and last name AND Personal Health Number. NOTE: Tests will not be done if the specimen is not labeled correctly. After collection, place the specimen back into the resealable plastic bag provided and place your requisition and this form in the outside pocket of the bag. Keep the sample at body temperature (for example, place in an inside pocket) from the time it is collected until it is delivered to the laboratory. Delivered to a Patient Service Centre in the Calgary area before 10:30 a.m. Monday to Friday or to Banff Mineral Springs Hospital Laboratory before 2:00 p.m. Monday to Friday. Samples will not be accepted at any other rural hospital laboratory, the Airdrie, Chestermere, Okotoks, Strathmore or Cochrane Patient Service Centres, or any Calgary hospital outpatient laboratory. Samples will not be accepted on Saturdays, Sundays, or statutory holidays. Give directly to laboratory staff. DO NOT place sample on counter or in a drop off box. | | | |
