- Ambulatory Clinic patients, immunocompromised patients and patients requiring special collections can obtain service at their respective hospital outpatient lab.

Why this is important:

- Hospital Outpatient Labs are available to collect patients that attend on-site Ambulatory Clinic appointments, immunocompromised patients and patients requiring special collections.
- <u>Patient Service Centers</u> are available to collect patients that have/will attend appointments with their family physician or other provider not in a hospital setting and patients that will attend a hospital clinic appointment and require bloodwork to be available for the clinician during that appointment.
- Patients attending either hospital outpatient labs or patient service centers may experience longer wait times as a result of Ministry directives to follow enhanced safety protocols related to COVID-19.

Actions Required:

- Healthcare providers should continue to follow established site processes for patient referrals to the Hospital Outpatient Laboratories. A single contact number (403-944-2285) for use by healthcare providers has been implemented to guide this process.
- Patients booking at PSCs should continue to use the online option at www.albertaprecisionlabs.ca or call 1-877-868-6848 to make an appointment.

Definitions:

Ambulatory Clinic patient	Patients that receive medical service at a hospital on an outpatient basis	
Immunocompromised patient	Patients that are taking immunosuppressive drugs/treatment, experiencing illness/injury or have an inherited disease affecting the immune system	
Special collections	Samples that require special handling, are not available at PSCs, or can only be collected in hospital outpatient labs. Includes collections such as: Ammonia, Cryoglobulin, Cryofibrinogen, Venous Blood Gas, Closure Time LifeMark, Research, Staff BBFE, and babies <1month old.	
Referrals	The formal process through which a health care provider arranges an appointment with another health care provider who provides specialist treatment or assessment	
Healthcare provider	Can include doctors, nurses (RNs, LPNs), dentists, psychologists, physiotherapists, pharmacists, and dieticians, etc.
