Re:	Introduction of Rapid, Decentralized COVID-19 Testing at QE II Hospital (Grande Prairie)

PLEASE POST OR DISTRIBUTE AS WIDELY AS APPROPRIATE

Key Message:

- Effective May 4, 2020 at 0800h, COVID-19 testing on specimens submitted from hospital inpatients at Queen Elizabeth II Hospital (Grande Prairie) and surrounding rural hospitals will be performed using the rapid GeneXpert[®] nucleic acid test (NAT).
- Acceptable specimens include nasopharyngeal swabs (FLOQSwab[®] in Universal Transport Media), throat swabs (eSwab[®] collection kit or polyester/cotton swabs in saline transport medium), endotracheal tube aspirates, and bronchoalveolar lavages.
- Specimens collected from patients in emergency departments, assessment centres, and in the community will continue to be forwarded to the APL Public Health Laboratory.

Why This Is Important:

- The GeneXpert[®] assay targets the N and S genes of SARS-CoV-2, the etiologic agent of COVID-19.
- Its performance is comparable to the laboratory-developed test used at the APL Public Health Laboratory. Additional confirmatory testing is not necessary.
- Because of limited supply, this test is currently being offered to hospital inpatients only. Work is ongoing to secure supplies to provide rapid, decentralized testing to more patients.


Action Required:

- Ensure all hospital inpatient orders for rapid COVID-19 are submitted in Meditech (see flow chart attached).
 - o If rapid COVID-19 testing is required, order as "rapid COVID-19".
 - o If COVID-19 testing is needed, but not urgently, order as "routine COVID-19".
 - If testing for other respiratory viruses is needed, order "RPP". The respiratory pathogen panel (RPP) will no longer be automatically performed on all COVID-19 tests.
- Repeat rapid COVID-19 test requests and testing of outpatients and emergency patients will continue to be sent to the APL Public Health Laboratories in Edmonton.
- All results will be available in Netcare. The results will not be viewable in Meditech.
- Contact and droplet precautions should only be discontinued in accordance with Infection Prevention and Control (IPC) guidelines or consultation and should take into account the patient's clinical and radiological findings.
