Re: Discontinuation of SECOND TRIMESTER syphilis screening on pregnant women

PLEASE POST OR DISTRIBUTE AS WIDELY AS APPROPRIATE

Background:

High rates of infectious syphilis in pregnant women resulting in congenital syphilis cases, was the rationale for introducing an enhanced prenatal syphilis testing program at the second trimester (24-28 weeks) and at delivery, in addition to routine testing in the first trimester or first prenatal encounter. A program evaluation of this enhanced testing protocol by Alberta Health and Wellness of the infectious syphilis cases in pregnant women together with congenital cases has shown that screening in the second trimester had limited value in identifying cases.

Key Message:

Although syphilis screening in the second trimester (24-28 weeks) is now discontinued, testing on pregnant women **<u>must be</u>** performed at:

- First trimester OR at any time if this is a first time prenatal encounter for syphilis, HIV, hepatitis B, rubella and varicella-zoster immunity, and the ABO/Rh and RBC antibody screen.
 - Use form HS0001-133 (Prenatal Testing Initial Screening for Pregnant Women)
 - Forms may be ordered online at https://secure5.datagroup.ca/acsc/request ext.asp
 - collect one gel separator tube AND one EDTA tube

AND

- > <u>At Delivery</u> for syphilis rescreening.
 - use new form HS0286 (Prenatal Testing Universal Syphilis Rescreening requisition -<u>http://www.health.alberta.ca/documents/Prenatal-Syphilis-Rescreen.pdf</u>)
 - check box 356 "universal syphilis rescreening at delivery"
 - collect one gel separator tube

Note: At ANY time during pregnancy for women at high risk for becoming infected or re-infected with syphilis; syphilis testing can be performed at multiple time points as required.

- use above new form HS0286
- check box 357 "syphilis rescreening unscheduled"
- collect one gel separator tube
